I hereby agree to care for the above described pet in a humane and responsible manner and to provide it with clean and adequate shelter, food, water and veterinary care. I further agree that said pet shall reside inside my home and shall not be allowed to roam freely.

I hereby agree that this pet shall wear a collar or harness with identification tags at all times.

I hereby agree that the adoption fee of \$ _____ helps to cover the current owner's expense of raising and caring for the animal and is not refundable after a trial period of 14 days.

I hereby understand and agree that the current owner makes no representations or warranties, expressed or implied, about the above mentioned animal's temperament or health and is hereby absolved from any liability for future damages or injuries caused by said animal. I also understand and agree that the current owner further gives no guarantees, expressed or implied, of the suitability of the animal to the adopter and/or his family.

I understand this is a "foster-to-adopt" agreement. Adoption to become final upon receipt of proof of sterilization at age-appropriate time, not to exceed one year from today's date.

Supplemental Agreement

We at Puppy Love Maternity Rescue believe communication is what makes successful adoptions. We consider ourself "family" to these puppies/dogs, and to their adopters. We ask that you continue to update us on you new family member, and ask for guidance if-and when- confusing situation arise. We have established a close collaboration with a professional dog trainer, who is offering free services to our adopters to ensure everyone gets off to a good start.

Heather Mazrahi is a professional dog trainer that we have chosen to collaborate with, as she reflects our values and training style. We at PLMR recognize that adding a puppy/dog to your family has unique challenges and great reward. In the interest of our puppies/dogs having good family connection and commitment, we ask that our adopters participate in training of their choice, with a one time, required, and free 30-minute video appointment with Heather.

We also ask our adopters to make every effort to provide a safe, happy and healthy home for their puppy/dog. If, in the first few weeks, the adopters realize they are not ready to fulfill the commitment of parenthood to our puppy/dog, we at PLMR will take back the puppy/dog.

If, after months of ownership, an adopter no longer wants the puppy/dog, we will participate in re-homing the dog- However, we may not have space available to "take the dog back". The adopter agrees to continue to care for the dog until other arrangements can be made, up to and including paying to board the animal if necessary. The adopter agrees not to "dump" the puppy/dog at any shelter.
